<u>Delegation – Dr. Brian Kotak /Stan Kaczanowski (via phone) Re: Pathways to Climate Change Resilience</u> Dr. Kotak did a power point presentation covering the following topics:

- MB Model Forest Who We Are
- Climate Change & Community Impacts / Resilience
- Steps RM of Victoria Beach has taken
- Pilot Project to test a new climate change

Dr. Kotak asked if council would be interested in participating in a pilot project (workshops) relating to climate change and its impacts. The Municipality would make a commitment to provide key personnel and the MB Model Forest would provide the expertise and funding to enable the project to take place.

Reeve Farrell thanked Dr. Kotak and Mr. Kaczanowski for their presentation and noted that council would consider the proposal and provide a response in due course.

Res. #2011/100 - McKibbin/Boyd

Whereas Subsection 173(1) of The Municipal Act provides that a council may by resolution borrow money for operating expenditures during a fiscal year, but the amount borrowed must not exceed the amount collected in taxes and grants in lieu of taxes in the previous fiscal year;

And Whereas the Rural Municipality of Victoria Beach collected municipal taxes and grants in lieu of taxes in the amount of \$3,385,983.65 in the 2010 fiscal year;

Therefore Be It Resolved That the Reeve and Chief Administrative Officer of the Rural Municipality of Victoria Beach be authorized to borrow, on behalf of the Municipality, from the Canadian Imperial Bank of Commerce such amounts not exceeding Two Hundred Fifty Thousand Dollars (\$250,000) as are required by the Municipality for operating purposes for 2011;

And Be It Further Resolved that, if required, the Reeve and Chief Administrative Officer shall be empowered to hypothecate and pledge, as security thereof, the taxes imposed and levied for the year 2011;

And Be It Further Resolved that the Reeve and Chief Administrative Officer be authorized to sign the Credit Facility Agreement with the Canadian Imperial Bank of Commerce dated April 26, 2011. Carried

Res. #2011/101 - Boyd/McKibbin

Whereas Manitoba NetSet has received government funding to install infrastructure enabling the provision of high speed internet;

And Whereas Manitoba NetSet is prepared to install a tower at Victoria Beach to provide high speed internet in a specified location at the municipal gravel pit site;

Now Therefore Be It Resolved That the R. M. of Victoria Beach council authorize the erection of a tower at the gravel pit site subject to the entering into of a written agreement between Manitoba NetSet and the Municipality. Carried

Res. #2011/102 - McKibbin/Boyd

Whereas the Alex Anderson Memorial Sports Club (AAMSC) leases municipal land (Part N ½ 10-20-7EPM) along PTH59 to locate its facilities and provide recreational opportunities to the Municipality's residents;

And Whereas the AAMSC is in the process of building a new community centre facility which will include a hall and curling rink;

Now Therefore Be It Resolved That the R. M. of Victoria Beach council authorize the AAMSC to further develop the municipal land it leases to enable construction of a new recreation centre providing all necessary building permits and approvals are obtained from the Province of Manitoba and any other authority having jurisdiction. Carried

Res. #2011/103 – Boyd/McKibbin

Whereas the R. M. of Victoria Beach council has authorized the sloping of banks and placement of rock at site specific areas along the lakefront in the King Edward / Alexandra / Patricia beach areas to address safety concerns and to provide protection to municipal stairs that are to be repaired and/or replaced;

And Whereas the timeline to complete this work was limited and the contractors were authorized to proceed on the understanding that council would ratify it's verbal commitment;

Now Therefore Be It Resolved That the R. M. of Victoria Beach council authorize the expenditure of \$40,000 (as specified/included in the 2011 Capital Budget) to cover the cost of rock protection, bank stabilization and improved anchoring of the municipal stairs. Carried

Res. #2011/104 - McKibbin/Boyd

That the R. M. of Victoria Beach council authorizes the Municipality's sponsorship of the 2011 Summer Winds Family Music Festival (SWFMF) and agrees to provide a \$500 contribution to the SWFMF Committee as a 2011 sponsor to the event.

That the R. M. of Victoria Beach council agree to increase the fee paid to Larry Ateah for hauling recyclables to Lac du Bonnet to \$450 per trip.
