- SETC provided with background information on findings

<u>Delegation – Chris & Nancy Kelly – Adventure Tree Service Re: Chipping Service</u>

Mr. & Mrs. Kelly were present to discuss the possibility of providing a chipping service as an option to the brush removal service provided by the Municipality. Matters discussed included:

- Chipping would be for deadfall only no leaves or any other refuse
- 12" chipper / 5-ton dump truck & employees included
- Can chip up to 12" trunk
- Chip stockpiles must be rotated large limbs to be left for public use

Delegation – Kevin Ateah – Re: Parking Lot Concerns

Mr. Ateah was present to discuss various concerns relating to the municipal parking lot. Items discussed included:

- Security cameras at parking lot entrance and exit
- RM could add a security camera for the Gate area cost ~ \$1,000
- Pole replacement at back of parking lot
- Future lot capacity concerns expansion will be required
- 2011 taxi rates may be increased due to fuel / operating costs
- Identification of taxis
